Background

- COP7 adopted capacity-building frameworks for developing countries (Dec. 2/CP.7) and for EIT countries (Dec. 3/CP.7)
- To guide capacity-building activities related to the implementation of the Convention and effective participation in the Kyoto Protocol process



Key provisions

- Urges GEF to adopt a streamlined and expedited approach in financing activities within this framework.
- To conduct a comprehensive review of the implementation of this framework at COP9 and every five years thereafter.
- To adopt a decision at COP/MOP1 containing a framework on capacity- building relating to the implementation of the Kyoto Protocol.

Scope of needs and areas

- Institutional, including strengthening...of national climate change secretariats or focal points
- Enhancement and/or creation of enabling environment
- National communications
- National climate change programmes
- GHG inventories, emissions database management...
- Vulnerability and adaptation assessment
- Cap-bldg. for implementation of adaptation measures
- Assessment for implementation of mitigation options
- Research and systematic observation...
- Development and transfer of technology
- Improved decision-making...participation in int'l. negotiations
- Clean Development Mechanism
- Needs arising out of the implementation of Art. 4&9
- Education, training and public awareness
- Information and networking, including establishment of databases

Capacity-building activities

- Preparation of NAI communications
 - GHG inventory
 - Public awareness and education
 - Vulnerability and assessment
- Preparation of NAPAs
- GEF National capacity self-assessment
- GEF Phase II of enabling activities
 - Technology needs assessments
 - Systematic observation
 - Public awareness
- CDM-related CB assistance

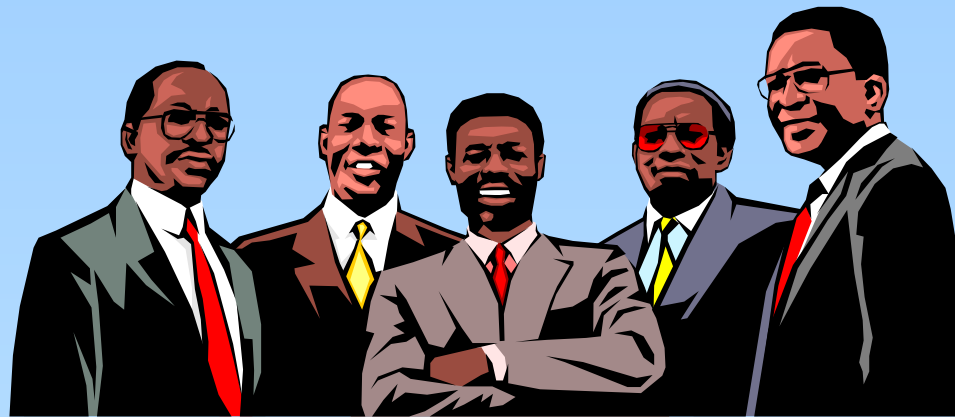


Initial analysis

- Scope of needs are broad and overlapping.
- Emerging gaps in CB activities i.e. institutional, information technology, databases, technical trainings, etc.
- Specific priority CB activities need to be identified

Considerations in implementing CB framework

- What specific, tangible and time-bound CB activities in each priority areas?
- What are the Parties' priority needs and what are the barriers in their effective implementation?
- What additional guidance may be given to GEF to ensure effective implementation of the capacity-building decisions?
- What would be an appropriate terms of reference for the comprehensive review?
- What could be possible elements that may be included in the draft CB decision related to KP?
